

Connecting and Using the Speaker

- Charge the speaker before using it by opening the rear cover and connect the speaker to an AC adapter (not supplied).
- 2 Charging a smartphone
- 1 Press the **Power** button on the speaker to turn it on.
- (!) You can only charge your smartphone in Bluetooth mode
- ② Open the back cover of the speaker and connect the smartphone to the • *** (5 V === 2 A) terminal via the USB cable. The smartphone starts to be charged.

3 Connecting to an External Device

- 1 Press the **Power** (b) button on the speaker to turn it on.
- ② Open the back cover of the speaker and connect the external device to the AUX terminal via a 3.5 mm stereo cable.
- 3 Turn the external device on and start playing.

- 4 Connect the speaker to a smartphone via Bluetooth
 - 1 Press the **Power** (b) button on the speaker to turn it on. **Bluetooth** LED blinks.
- (3) Find "LG-XG7Q (XX)" on the device list on the smartphone and connect to it. Once the smartphone is connected via Bluetooth, the Bluetooth LED will turn on.
- On the smartphone, play a music of your choice.

- **5** Connecting the LG XBOOM App
- Tind LG XBOOM app on the Google Play or App Store and install it on your smartphone.
- (2) Run the LG XBOOM app and use more features. (EQ, Wireless Party Link, Lighting, Sleep Timer, Setting etc.)

If you and LG are unable to resolve the dispute within 30 days, either party may proceed to file a claim for arbitration.

Agreement to Binding Arbitration and Class Action Waiver. Upon failure to resolve the dispute during the 30 day period after sending written notice to LG, you and LG agree to resolve any claims between us only by binding arbitration on an individual basis, unless you opt out as provided below. Any dispute between you and LG shall not be combined or consolidated with a dispute involving any other person's or entity's product or claim. More specifically, without limitation of the foregoing, any dispute between you and LG shall not under any circumstances proceed as part of a class or representative action. Instead of arbitration, either party may bring an individual action in small claims court, but that small claims court action may not be brought on a class or representative basis.

Arbitration Rules and Procedures. To begin arbitration of a claim, either you or LG must make a written demand for arbitration. This arbitration provision is governed by the Federal Arbitration Act. Judgment may be entered on the arbitrator's award in any court of competent jurisdiction. All issues are for the arbitrator to decide, except that issues relating to the scope and enforceability of the arbitration provision and to the arbitratility of the dispute are for the court to decide. The arbitratior is bound by the terms of this provision.

Governing Law. The law of the state of your residence shall govern this Limited Warranty and any disputes between us except to the extent that such law is preempted by or inconsistent with applicable federal law.

Fees/Costs. You do not need to pay any fee to begin an arbitration. Upon receipt of your written demand for arbitration, LG will promptly apall arbitration filing fees to the AAA unless you seek more than \$25,000 in damages, in which case the payment of these fees will be governed by the AAA Rules. Except as otherwise provided for herein, LG will pay all AAAA filing, administration and arbitrator fees for any arbitration initiated in accordance with the AAA Rules and this arbitration provision. If you prevail in the arbitration, LG will pay your attorneys' fees and expenses as long as they are reasonable, by considering factors including, but not limited to, the purchase amount and claim amount. Notwithstanding the foregoing, if applicable law allows for an award of reasonable attorneys' fees and expenses, an arbitrator can award them to the same extent that a court would. If the arbitrator finds either the substance of your claim or the relief sought in the demand is frivolous or brought for an improper purpose (as measured by the standards set forth in Federal Rule of Civil Procedure 11(b)), then the payment of all arbitration fees will be governed by the AAA Rules. In such a situation, you agree to reimburse LG for all monies previously disbursed by it that are otherwise your obligation to pay under the AAA Rules. Hearings and Location.
